



## **“Think Visegrad” - V4 Think Tank Platform**

*Project Report Document*

*January 2020 – January 2021*

*February 2021*

Three pillars, on which the “Think Visegrad – V4 Think-Tank Platform” is based, remained without change despite the unprecedented challenge represented by the COVID 19 pandemic. The platform’s experts worked to both *short- and long-term analyses*, while initial activities were also undertaken in relation to *Civil Servants Mobility Program (CSMP)*, as well as *Think Visegrad Fellowships* for non-V4 fellows. The platform also successfully organized the *V4 Presidency Mid-Term Review Conference*, though in the online format. Through the *Think Visegrad in Brussels* project the platform has also continued to increase its visibility in Brussels.

The *core network* of think tanks has remained stable, containing eight think tanks (two per each V4 country). The platform has also remained *open to cooperation* with think tanks and experts from outside (for the list of the “core network” members and other participating think tanks please see Annex 1).

As a follow up of the debate on some procedural revisions, which the Think Visegrad platform conducted with the V4 policy planners, some changes were implemented in the development of *short-term analyses*. The number of analyses was reduced from 12 to 6 and the time frame for their development was extended. At the same time, assignments were formulated in a more detailed manner. In addition, a more intensive communication mechanism between the authors of each analysis on one side and the representatives of the MFA of the V4 President country was established. Implemented changes aimed to improve the quality of the development process, as well as to provide the authors with a valuable feedback at different stages of their work (for the list of short- and long-term analyses see Annex 2).

Think Visegrad core network members also choose *8 visiting fellows from non-V4 countries*, who were supposed to spend their fellowships in the respective think tanks. However, due to the spread of the COVID 19 pandemic 3 fellowships were postponed to 2021 (for the list of “Think Visegrad” visiting fellows from non-V4 countries see Annex 3).

The implementation of the *Civil Servants Mobility Program* was severely affected by the COVID 19 pandemic. Long-term travel restrictions did not allow the Think Visegrad members to proceed with the study trips for civil servants from Ukraine, Kosovo and Georgia. In fact, the 2020 edition of the program was postponed to the 2021.

The organization of the *V4 Presidency Mid-Term Review Conference* also experienced significant difficulties due to the spread of the pandemic. Originally scheduled for April, the conference was moved to 22 September. Due to travel restriction for the participants, it was only organized as an online event. Thematically the conference focused on the impact of the COVID 19 pandemic both on the EU, as well as global level, while taking into the consideration the point of view of the V4 countries. The main organizer was EUROPEUM Institute for European Policy from Prague. As a side event of the conference, the online meeting with the IVF Director Edit Bátorfi was organized. Think Visegrad platform coordinators also had their online meetings throughout the year.

On the basis of the agreement with the IVF director Edit Bátorfi, a *public follow up of the mid-term conference* was organized on the topic “Future of the EU after COVID 19”. Besides experts from the Think Visegrad platform, the public event was also attended by the Czech deputy foreign minister Aleš Chmelař and his Slovak counterpart Martin Klus.

The project *Think Visegrad in Brussels*, led by EUROPEUM, continued to enjoy active support of all Think Visegrad platform core members. The main focus was on the organization of online events, both public and closed, since the implementation of the fellowships part was heavily affected by the COVID 19 pandemic.

The beginning of the Polish V4 Presidency (2020-21) was marked by the organization of an *online chat with the Polish minister of Foreign Affairs* Jacek Czaputowicz for the experts from V4 think tanks. Think Visegrad experts had a unique opportunity to discuss various issues of their interest with the foreign minister of the presiding country. This initiative might become an inspiration for the following V4 Presidencies.

It is worth to mention that all analyses developed by Think Visegrad experts continued to be *available exclusively for the MFAs of the Visegrad countries*. The equal rights, equal contribution principle in Think Visegrad was demonstrated by the nomination of authors of both short- and long-term analyses, while the *Visegrad spirit of cooperation* was maintained through the engagement of the authors from all V4 countries in case of each of the analyses. Last but not least, the Think Visegrad platform continued to implement all the activities in a very *cost efficient way* (for the financial report please see Annex 4).
